ARINDAM CHAKRABARTI is Professor in the Department of Philosophy, University of Hawai‘i, Manoa, where he was formerly the Director of the Center for South Asian Studies. After his doctoral work at Oxford on philosophy of language, he taught analytic philosophy and Indian philosophy at Calcutta, London, Seattle, and Delhi. FRANCIS X. CLOONEY, S.J., is Parkman Professor of Divinity and Comparative Theology at Harvard University. His primary areas of scholarship are theological commentarial writings in the Sanskrit and Tamil traditions of Hindu India and the developing field of comparative theology, a discipline distinguished by attentiveness to the dynamics of theological learning deepened and complexified through the study of traditions other than one's own. Professor Clooney is the author of numerous articles and books, including *Hindu God, Christian God* (Oxford University Press, 2001), *Beyond Compare: St. Francis de Sales and Sri Vedānta Deśika on Loving Surrender to God* (Georgetown University Press, 2008), and *The Truth, the Way, the Life: Christian Commentary on the Three Holy Mantras of the Srivaishnava Hindus* (Peeters Publishers [Leuven], 2008).

CHRISTOPHER G. FRAMARIN is an assistant professor in the Philosophy and Religious Studies departments at the University of Calgary. He is author of *Desire and Motivation in Indian Philosophy* (Routledge, 2009). He is currently working on a book on the value of animals in the Hindu tradition.

KATRIN FROESE is an associate professor of Religious Studies and Philosophy at the University of Calgary. Her current research compares continental European and Chinese philosophical traditions. She is the author of *Nietzsche, Heidegger and Daoist Thought: Crossing Paths In-Between* (SUNY, 2006) and *Rousseau and Nietzsche: Toward an Aesthetic Morality* (Lexington Books, 2001).

CHEN-KUO LIN is University Professor of Buddhist Philosophy in the Department of Philosophy and Graduate Institute of Religious Studies at National Chengchi University, Taiwan. In 1999–2000, he was invited to hold the European Chair of Chinese Studies at the International Institute of Asian Studies, The Netherlands, and taught at the Institute of Sinology, Leiden University. His research project focuses on the issues of language and knowledge in the Mādhyamika and ogācāra schools. He is also interested in bridging dialogues between Buddhist philosophy, Continental philosophy (phenomenology, hermeneutics, and deconstruction), the Kyoto School, and modern Confucianism. His intellectual journey can be surveyed in two books: *Emptiness and Modernity: From the Kyoto School, Modern Neo-Confucianism to Multivocal Buddhist Hermeneutics* (Taipei: New Century Publication, 1999) and *A Passage of Dialectics* (Taipei: New Century Publication, 2002).

DAN LUSTHAUS (PhD, Temple University) has published extensively on Indian and Chinese philosophy and religion. Publications include *Buddhist Phenomenology: A Philosophical Investigation of Yogācāra Buddhism and the Ch'eng wei-shih lun* (Routledge Curzon, 2002), *A Comprehensive Commentary on the Heart Sūtra (Prajñāpāramitā-hṛdaya-sūtra) by K'uei-chi* (translated in collaboration with Heng-Ching Shih) (Berkeley: Numata, 2001), and numerous articles on Buddhist, Hindu, and Daoist thought. He has taught at UCLA, University of Illinois Champaign-Urbana, and Boston University, and has been a research associate at Harvard University since 2005.

MICHAEL MCGHEE is Senior Fellow in the Department of Philosophy at the University of Liverpool. With the publication of his book, *Transformations of Mind: Philosophy as Spiritual Practice* (Cambridge University Press, 2000), he charted new waters for the practice of comparative philosophy of religion. A pioneer in the engagement of analytic philosophy with Buddhist (primarily *mahāyāna*) thought, McGhee develops a sophisticated hermeneutics of suspicion from the Buddhist perspective, interrogating Anglo-American philosophical presuppositions of neutrality and rationality. He is also the author of various articles on themes in aesthetics, ethics, and the philosophy of religion.

MICHAEL OPPENHEIM is a professor in the Department of Religion at Concordia University in Montreal. His latest book, *Jewish Philosophy and Psychoanalysis: Narrating the Interhuman* (Lexington, 2006), compares the work of Jewish philosophers of encounter (Rosenzweig, Buber, and Levinas) with post-Freudian psychoanalysts (Klein, Erikson, Fairbairn, Winnicott, and Irigaray). He has published books and articles in the areas of modern Jewish philosophy, Judaism in the modern period, philosophy of religion, and psychology of religion.

TINU RUPARELL is an associate professor in the Department of Religious Studies at the University of Calgary. Trained in both analytic and Continental philosophy, he is particularly concerned to put these modes of thought into comparative conversation with Hinduism. He has published and presented widely in intercultural philosophy, focussing on the areas of interreligious dialogue and comparative hermeneutics. He is the author of the forthcoming *Dialogue and Hybridity* (Albany: SUNY Press, 2012) and has coedited *Encountering Religion* (Oxford: Blackwells, 2001) and *Christian Thought in the 21st Century* (Eugene, Oregon: Wipf and Stock, 2011).

VINCENT SHEN is the holder of Lee Chair in Chinese Thought and Culture, Department of East Asian Studies and Department of Philosophy, University of Toronto. His research interests lie in the area of Chinese Philosophy, Comparative Philosophy, Phenomenology and Philosophical Problems of Technology, Culture and Religion. His recent publications include *Philosophy of Paul Ricoeur* (Taipei: Sanmin, 2000), *Contrast, Strangification and Dialogue* (Taipei: Wunan, 2002), *Technology and Culture* (Taiwan: Open University Press, 2003), *Ideas of University and Spirit of Strangification* (Taipei: Wunan, 2004), *An Anthology of Shen Tsing-song* (Jinan: Shandong Education Press, 2005) and *Confucian Ethics in Retrospect and Prospect* (edited with Kwong-loi Shun, Washington, DC: Council for Research in Value and Philosophy, 2007).

AHMAD F. YOUSIF is currently a professor at the International Institute of Islamic Thought and Civilization, in Kuala Lumpur, Malaysia. He has previously taught at the University of Winnipeg, the University of Ottawa, the International Islamic University Malaysia, and the University of Brunei Darussalam. Yousif teaches postgraduate courses on religious and Islamic studies. He is the author of three books, and numerous articles published in scholarly journals. As a professor of Islamic Studies, Yousif is widely credited for having pioneered research concerning Muslims in Canada, Islam in Southeast Asia, and Comparative Religion.

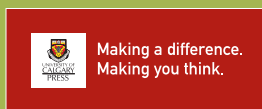
While the division between the two disciplines of Religious Studies and Philosophy is commonplace in western academia, this bifurcation does not necessarily apply in non-western settings, where religion and philosophy tend to be integrated. As a result, when the disciplines are virtually mutually exclusive, as in the West, a full appreciation of non-Western approaches to either religion or philosophy is not easily attained, and distortions, such as appropriation, often occur. Within the last ten years, there has been a concerted effort on the part of a number of Western scholars to try to address these deficiencies and re-examine many ideas that have been misappropriated or otherwise excluded. These errors have resulted from a traditional approach where the religions and philosophies of non-Western peoples have been interpreted by reducing or manipulating their ideas and values to fit within Western concepts and categories. This project is conducted with full awareness of the post-colonial critique of such enterprises. One of the central questions addressed is how comparative philosophy and religion would change if the concepts and categories of non-Western philosophies and religions were taken as of equal importance.
